BASE FEE SCHEDULE

Fee schedule - Customs clearance

Entry fee per air waybill M-F, 8:00 AM - 4:30 PM - First shipment and minimum fee, up to two hours	\$250
Entry fee after business hours and weekends - up to two hours	\$450
Entry fee on local, state or federal holidays in the city where the entry is filed - up to two hours	\$500
<i>Overtime services after two hours - normal business hours</i>	\$100/hour
<i>Overtime services after two hours - after business hours, weekends and holidays</i>	\$200/hour

Fees for duties, taxes and additional services

Merchandise Processing Fee (MPF) for informal entry (personal pet, under \$2,500)	\$2.18
Merchandise Processing Fee (MPF) for formal entry (breeder, resale, \$2,500 and above)	\$27.23
Customs bond (required for formal entry)	\$75
Fish & Wildlife clearance (if required)	\$100
Fish & Wildlife inspection (if required)	Minimum \$100
Airline terminal fees (if required)	Minimum \$60
Messenger service	\$25

REQUIRED IMPORT DOCUMENTS

Owner/Breeder/Importer

The following documents are needed from you, prior to your pet(s) departure from the origin country. All must be in English, valid, and legible.

- Power of Attorney--signed by consignee, showing IRS# or Social Security Number, and consignee's date of birth.
- U.S. Government issued Identification: Drivers License, Passport, or Visa.
- Foreign Importers (non-US citizens): Coppersmith can file for a Customs Assigned Number on your behalf. Please show your **foreign address** on the Power of Attorney.

Pet/Animal

Entry into the United States requires the following documents regarding your animal. Documents must show your pet's name, date of birth, gender, species, and breed.

- Invoice for customs purpose--showing description, ownership, value. (Proforma available upon request)
- Health Certificate, Rabies Certificate, Vaccination Card and any other pertinent documents.
- Air Waybill
